#### **Treasurer's Report**

- I became Treasurer in February 2023. One of my first tasks was to understand how our funds were invested and how we could obtain a greater return on our investment.
- In February, the Capital Reserve and Improvement Accounts, along with a Capital Reserve CD, were closed
  out at MCT and those funds were moved to Morgan Stanley. In March, I then began working on the 202324 budget. I wanted to have a conversation with the membership to hear their concerns and comments.
  That meeting happened in April. It is my intention to again have a similar membership meeting in April of

- 2024 to discuss the budget for the 2024-25 fiscal year. I believe it is very important to obtain the membership's feedback in preparing the budget.
- It was not an easy decision to report to the membership that the dues would be going up \$100 for the 2023-24 fiscal year. In October 2023, I reported to the membership and the Board that there was a \$41,000 deficit for the 2022-23 fiscal year. Utilities, salaries, pool, lake & dam, and security were several of the reasons for the deficit. In the 2023-24 fiscal year, the following were expensed:

 We have engaged Connolly, Grady & Cha to perform the audit for the 2022-23 fiscal year. As of October 6, all information has been provided to conduct the audit and to complete the tax return. Finally, I have obtained five proposals for an on-site Reserve Study. The Long-Range Planning Committee will be reviewing the proposals and provide their input on making their recommendation.

## What is an Executive Session and Why Does the Board Have Them?

- Section 5.11(c) of the BCLCA bylaws provide that the Board may "conduct portions of meetings in executive sessions." What are executive sessions? Executive sessions are closed sessions of the Board attended only by the Board members, and those persons necessary, usually the BCLCA lawyer, to conduct the matter at hand. They are an exception to the general rule that the Board meetings are open to all BCLCA members in good standing. Executive sessions may be called before, during, or after a Board meeting. For the convenience of members attending the open meeting, the Board typically calls executive sessions near the end of the meeting, unless there is a good reason to do otherwise.
- There are no minutes or recordings of what is discussed in executive session. A Board member breaches the fiduciary duty he or she owes to BCLCA if he or she does not keep confidential what is discussed in the executive session, unless and until such time as the Board as a whole decides otherwise.
- What is discussed in executive session? The BCLCA bylaws provide, "In executive session, the Board may only discuss matters that are confidential, privileged or involve personal privacy, such as personnel issues, legal matters or similar subjects as may [be] deemed appropriate by the Association's legal counsel." That last phrase,

- "similar subjects as may [be} deemed appropriate by the Association's legal counsel" is very broad. Unfortunately, unlike the Sunshine Act, which applies only to political subdivisions and not property owners' associations, there is no statute which explicitly states what can be discussed in executive session; and there is very little caselaw on this subject. Having said that, all of the Boards which I have represented at BCLCA have taken a very restrictive view on what can be discussed in executive session. This fosters both transparency and trust. No Board wants to be accused of "doing things behind closed doors."
- In support of this concept, nothing discussed in executive session becomes effective unless and until the Board, following the executive session, reconvenes in open meeting and approves the action discussed in executive session. In this way, the Board balances its duty to keep the members informed of what it is doing with the reality that certain matters, for legal or practical reasons, cannot be discussed in an open meeting.

• The Technology Committee, in cooperation with the Lake & Dam Committee, is working on a project to bring Wi-Fi to the beaches and boat launch. The system will provide free wireless Internet to residents and guests enjoying the beaches and boat launch, and deploy network infrastructure for supporting BCLCA services and needs in the future, such as security cameras. The beach and boat launch systems could be solar-powered to avoid installation and monthly costs for utility electric service, and we intend on utilizing volunteer Technology Committee technical capabilities and maintenance department resources to complete the project.

#### **Environmental Committee**

The committee met virtually on September 11 and announced that Bill Allison, the newest Board member, would lead Environmental as Chairperson. Environmental volunteers plan to meet October 11 to plant new trees, and those previously purchased, and also to remove the Barberry from around Stewart Hall. #### Lake/Dam Committee

- · The Lake and Dam Committee has been very busy this year.
- This spring, we dredged the boat launch, installed the docks, added a bike rack, and installed a handicapped Porta Potty. We stocked 500 walleye in the spring, and we are intending to stock 500 more this fall. We launched a web-based fish survey with mobile device QR codes on the bulletin boards, as well as a link on the website, so that members and their guests can help us capture data on what the fish anglers are catching and use the information to help with lake management decisions.
- The lake was treated for weeds, and water testing for nitrates and nitrites has been ongoing. At the beginning of the season, we had the beaches cleaned and raked. Each summer, we inevitably must close one or both beaches temporarily due to bacteria in the water. We were fortunate this past season to have the beaches closed only a few times.
- The Committee has been reviewing recommended dam modification options from our engineering firm to bring the dam spillway up to current PA State requirements and we are obtaining quotes for outflow pipe inspection, a periodic dam maintenance task.
- We have completed plans for an erosion mitigation project for both beaches, have filed for DEP approval, and intend to have this project completed before winter.
- We hope everyone had a great season at the lake, and we will continue to make improvements so we can continue to preserve and enjoy our great lake and beaches.

#### **Maintenance**

#### **Permit Notes**

- If you are a property owner within BCLCA, looking to build a new home or addition, the permit requirements are listed in BCLCA'S Rules. Also listed within the rules, are the permit requirements for the new construction of sheds, decks, and fences. It is important to know that all Covenant restrictions and setbacks are found in the property's full deed on file at the county courthouse. Furthermore, certain Penn Forest Township setbacks and requirements can be more restrictive than BCLCA'S and take precedent. Just remember to review all the requirements within both BCLCA'S rules and PFT office when applying for a project permit.
- For your convenience, there is a list of required permits for Penn Forest Township posted on the BCLCA office lobby bulletin board.

#### Rules

- The Rules Committee is continuing the process of reviewing our Rule Book with the goal of making our rules as clear as possible, along with making updates where needed. Our rules have to be adapted constantly in line with our experiences and the events we encounter. Rule changes are discussed at Board meetings, so please attend these meetings in person or via Zoom to keep up-to-date on what is occurring in our community.
- Rule change highlights since the Spring Newsletter: 1. Fees increased and requirements changed for replacing lost Identification Badges and/or Parking Placards. An escalating cost and fine structure, per occurrence, along with the member returning all remaining badges and placards before replacements are issued. (See Rule Book on BCL website for further information), 2. When a proposed new rule(s) is introduced at a Board meeting, members have until the next scheduled Board meeting, which must be a minimum of 21 days from the date the rule is introduced, to submit or present their comments. If the rule

- or amended rule is approved at that next Board meeting, it may be effective immediately, or on a date specified by the Board., 3. All Short & Long-Term Rentals are now accessed an annual fee \$250 for STR and \$100 for LTR., 4. Established a minimum age requirement of (25) years for the primary renter of any rental property.
- A few important reminders: You must be at least 12 years old to drive a golf cart, and you must be accompanied by an individual 15 or older.
   Violators could be subject to a citation and/or fine.
- Please do not feed the wildlife. The animals have been here long before us and can survive on their own. Feeding corn to deer in the winter can cause them serious health problems which can become fatal. Also, feeding deer or birds may attract bears. It is unlawful to continue to feed wildlife that unintentionally attracts bears. (See Title 58, Chapter 137.33, PA Game & Wildlife Code). It is also against the law in PA to intentionally feed bears. Please notify the PA Game Commission at 833-742-4868 if you observe anyone feeding bears.

#### Security

Madeline Ligenza and Dawn Gallo

- The first order of business is to introduce Dawn Gallo who will be working with me on the Security Committee. Dawn is a fellow Board member and is very gracious and caring, and we will be working as a team.
- Security is not a Police Force. Security is in BCLCA to uphold the rules set forth in our community.
- Issued citations seems to be criticized by residents. Actually, so far
  this fiscal year, these are the citation statistics: 66 citations issued (48
  members, 18 non-members), collected \$6040 (\$5615 members, \$425
  non-members), unpaid \$1265 members, \$935 non-members). Some
  non-members actually do pay their citation fines. This was questioned
  at a board meeting.
- Issuing 66 citations in a fiscal year is not that many. However, there are
  residents who complain they are "targeted". The concept of issuing a
  citation is because a rule of BCLCA has been violated and the violation
  observed; therefore, a citation is issued.
- Citations are not issued to gain "revenue". Please keep this in mind.
   The purpose of citations is to enforce the rules set up by BCLCA.
- If you check the Committee reports on our website, the most common rules not being obeyed are: speeding, illegal parking, illegal garbage, unattended fires, trespassing and trespassing on the breast of the dam, failing to stop at stop signs, and no badge ID at an amenity.
- Raising seven children and then providing driving lessons was a real challenge. My father taught me and he was strict with driving rules. He told me to stop and count to three before proceeding. I learned to drive in NYC. Trying to enforce this rule with my children was a task. They finally realized why. Most drivers in BCLCA tend to roll through stop signs. I follow them down Midway all the time and shake my head.
- As it has been indicated many times, please read the Rule Book.

- Operators of golf carts must be 12 years of age or older. Children between ages of 12 to 14 must be accompanied by an individual 15 or older when operating a golf cart.

- Crime Watch is an extremely integral part of BCLCA. They are your eyes and ears in the community. They contribute many hours of their time and gas. Some members do walking tours also.
- There are about 24 members, depending on the time of year, since some are not here during the colder months but return to duty in the warmer months.
- As was explained at the August meeting, an approximate calculation
  of time spent and gas mileage was presented. A rough calculation
  regarding 365 days per year times two people on a given day of the
  schedule would be 730 man-hours per year at approximately \$9.00
  per hour (volunteers are not paid) would be \$6,570.00. Calculating
  approximately ten miles per shift at \$3.89 (summer price of gasoline)
  depending on the vehicle, is \$2,839.70. A rough calculation of what it
  would hypothetically cost to operate Crime Watch, would be \$9,409.70.
- Some of the Crime Watch vehicle signs are old and in poor condition.
   Five new sets have been purchased and will be replacing those that are in bad condition.
- These volunteers are proud to contribute to our community. If they are
  asked to serve extra shifts on holiday weekends, they comply. The
  schedule is sent out every Friday morning and is usually filled by the
  end of the weekend. We hold meetings when necessary.

#### **STR Committee Update**

- At the August Board Meeting, the Board decided not to pursue a Bylaw or declaration amendment at this time. Penn Forest Township (PFT) has the authority to enforce their rules and has a pretty good set of rules. Below is a summary of the current PFT ordinance and information on how to report violations. It is important to make sure that violations are reported properly, in a timely fashion, so that the rules can be enforced. Please make sure you are only reporting violations to the ordinance, as false reports can have a \$1,000 fine.
- There are 2 ways to report a violation:
  - Submit a Short-Term Rental Complaint through the PFT website: https://pennforest-pa-str-complaints.deckard.com/
  - Call the 24/7 Hot Line Phone Number: 855-255-5767

#### Summary of PFT Rules for STRs:

 Unreasonable Noise: Any sound that is plainly audible to an unaided human ear at any boundary line of the lot(s) or parcel(s) of land on which the Short-term Rental (or any activity, operation or use related to or associated with the Short-Term Rental) is located between the hours set forth below (1) for a continuous period in excess of fifteen (15) minutes, or (2) more than a total of thirty (30) minutes in any four (4) hour period:

Sunday 9:00PM to Monday at 8:00AM 9:00PM to 8:00AM Friday & Saturday 12:00AM to 8:00AM

- On the following holidays, the hours for the noise restrictions are from 2:00AM to 8:00AM: New Years Day, Memorial Day, 4th of July, Labor Day.
- Overnight occupants not to exceed an average of two persons per bedroom (i.e., number of occupants/number of bedrooms = average) plus four additional persons per residence. Children (2 years old or younger) shall not count towards the limit of overnight occupants. (Example, 3 bedrooms have the maximum of 10 overnight guests.)
- The number of bedrooms permitted for a short-term rental shall not exceed the number of bedrooms approved for the dwelling unit on the sewage permit issued.
- The use of open fires, fire pits, charcoal-burning grills or other devices (as applicable) shall be the responsibility of the owner or contact person and shall comply with Ordinance No. 08-05 (An Ordinance of the Township of Penn Forest Restricting Fires and Open Burning; and Prescribing Penalties for Violations). All open fires shall be extinguished by midnight.
- Limitations on how to market the rental. Must match information on license, occupancy, bedrooms, rental license number, property address. Advertisement must be submitted to PFT Enforcement Officer.
- · Violations, Penalties, and Costs
  - Failure to comply with any provision subjects the owner to criminal

prosecution and the revocation of any short-term rental license previously issued. The fine of not more than \$1,000 per day, per violation, together with costs, including reasonable attorney fees.

- License Revocation. If an owner is convicted of three (3) violations which occurred in any rolling twelve (12) calendar month period, then the license shall be revoked by the Township for one (1) year and the short-term rental must be discontinued while the license is revoked. The conviction of a fourth or more violations shall be cause for permanent revocation of the license. Any violation of the PA Sewage Facilities Act and applicable regulations may result in immediate license revocation until the violation is corrected.
- Please see the PFT website for the official rules and information.
   There have been multiple modifications to the STR rules by PFT, which we tried to incorporate into this summary. We cannot guarantee that the summary provided is the latest information.
